Sub: Appointment to the post of Assistant Executive Engineer (Civil) in Group-A of Odisha Engineering Service pursuant to Advt. No. 01 of 2019-20

Sir,

I am directed to say that in order to fill up the vacancies in the rank of Assistant Executive Engineer (Civil), the OPSC have recommended 353 Nos. of successful candidates vide their Letter No. 7187 /PSC, dtd. 31.12.2020 (Copy enclosed). Orders of Hon'ble Chief Minister have been obtained to allot 353 Nos. of successful candidates for appointment as Assistant Executive Engineer (Civil) in Group-A of Odisha Engineering Service in different Departments subject to the conditions mentioned below.

The services of the 12 (Twelve) nos. of successful candidates (list enclosed) are hereby placed at the disposal of H&UD Department for their appointment in Group-A service carrying the scale of pay at pay Level 12 of pay matrix under ORSP Rules-2017 with usual D.A. and other allowances subject to outcome of the decision of the Hon'ble High Court Orissa in W.P. (C) No.-30386 of 2020, filed by Sri Prafulla Kumar Behera in W.A. No.-733 of 2020 & I.A. No.-1614 of 2020 and other conditions laid down as follows:

1. The Inter-se-seniority of successful candidates shall be determined by respective Department in their respective Engineering Cadre in order of merit as assigned to them in OPSC merit list.
2. The candidates may be referred to the Medical Board in pursuance to Rule- 8 (3) of the Odisha Engineering Service (Methods of Recruitment & Conditions of Service) Rules, 2012 for obtaining fitness certificate of health before the issue of the appointment order on regular basis.
3. The candidates of PH Category may be referred to the pre-employment Appellate Medical Board for ensuring the correctness of their claim as regard to disability for their regular appointment.
4. The name of the candidates may be referred to concerned Collector & District Magistrate for verification of character and antecedents in pursuance to GA Department Resolution No.-34438, dtd. 20.11.1999.
5. The principle for first posting of all newly recruits may be followed as per GA&PG Department Resolution No-14327/GAD dtd 4<sup>th</sup> July 2017.
